- The day aims to ensure right to equality, inclusion and protection of all people without any discrimination in their law and policies to live a full life with dignity regardless of any barriers.

## Civil Accounts Day-2 March

   the resolution concerning the same in April 2021.

## World Rotaract Day -13th of March

- Every year, Rotaractors and Rotarians around the world celebrate World Rotaract Week during the week of 13 March to commemorate the founding of the first club in 1968 at North Carolina, USA.
- The theme of World Rotaract Day 2022 is "Rotary Making a Difference".
- World Rotaract Week will be held from 11 March 2022 to 18 March 2022.

## International Day of Mathematics- 14 March 2022

- International Day of Mathematics is observed on 14th of March every year.
- It is also known as the Pi Day because the mathematical constant π (pi) can be rounded down to
   3.14.
- The theme for 2022 IDM is "Mathematics Unites!".
- The proclamation of March 14 as the International Day of Mathematics was adopted in the 205th session of the UNESCO's Executive Council.

## World Consumer Rights Day - 15th March:

- The consumer movement marks 15th March with World Consumer Rights Day every year, as a means of raising global awareness about consumer rights and needs.
- This year the International Consumer Rights Day will be celebrated on the theme of "Fair Digital Finance."
- World Consumer Rights Day was inspired by President John F Kennedy, who sent a special message to the US Congress on 15th March 1962.

## International Day of Action for Rivers: 14 March

- International Day of Action for Rivers, observed on March 14 every year, is a day that is
  dedicated to saving, celebrating, and creating awareness about the importance of rivers
- The year 2022 marks the 25th anniversary of the International Day of Action for Rivers.
- The theme in 2022 is The Importance of Rivers for Biodiversity".

## National Vaccination Day-16th March:

- National Vaccination Day is observed annually on 16th march in India.
- The occasion is celebrated to raise awareness about importance of vaccination.
- The first dose of oral polio vaccine got started in the year 1995 in India & the last case of polio was reported from Bengal in 2011.

## International Day to Combat Islamophobia- March 15:

- The UN General Assembly adopted a resolution to proclaim March 15 as International Day to Combat Islamophobia.
- Objective: It will be curtailing systematic hate speech and discrimination against Muslims; respect
  for religious symbols and practices; along with the elimination of all forms of intolerance and
  discrimination based on religion or belief.

#### Global Recycling Day: 18th March:

- Global Recycling Day, celebrated on March 18 every year, is a recycling initiative that encourages us to look at our trash in a new light.
- Theme for 2022 is "recycling fraternity".
- The theme recognises the people who put themselves on the frontline to collect waste and recycling during the multiple lockdowns.
- The Global Recycling Day was created in 2018 by the London-based Global Recycling
   Foundation to promote the concept and practice of recycling.

## World Sleep Day 2022:

- The World Sleep Day is held every year on the Friday before Spring Vernal Equinox.
- In 2022, the World Sleep Day falls on March 18, 2022.
- The theme of 2022 is 'Quality Sleep, Sound Mind, Happy World'.
- The World Sleep Society first observed World Sleep Day in 2008.

## International Day of Happiness:

- The International Day of Happiness is celebrated throughout the world on 20 March.
- The theme for Happiness Day 2022 is **Keep Calm, Stay Wise and Be Kind.** Bhutan initially prioritized the value of National Happiness over National Income in the 1970s.
- Bhutan is known for adopting the goal of Gross National Happiness over Gross National Product at the 66th General Assembly.

It was established by the United Nations General Assembly on 28 June 2012.

## India's Ordnance Factories' Day: 18 March

- Ordnance Factory Day is observed across India on 18 March to commemorate the foundation of the first ordnance factory at Cossipore near Kolkata in the year 1801.
- The Indian Ordnance Factory Board (OFB), which comprised 41 institutions, ceased to exist from
   1 October last year.
- The OFB was split into seven public sector undertakings (PSUs), which continue to supply the country's armed forces with a variety of military equipment.
- OFB was founded in 1775 and its Headquarters is in Ayudh Bhawan, Kolkata.

## International Day for the Elimination of Racial Discrimination:

- The International Day for the Elimination of Racial Discrimination is observed annually on 21
   March.
- The 2022 edition of the International Day focuses on the theme "VOICES FOR ACTION AGAINSTRACISM".

## Central Reserve Police Force (CRPF)-83rd Raising Day:

- The CRPF Raising Day is held on March 19 after India's first Home Minister Sardar Vallabhbhai
   Patel presented colours to the CRPF following the enactment of the CRPF Act by the Parliament in 1950.
- The CRPF was raised in 1939 and was then known as the Crown Representative's Police.

#### International Day of Forests-21 March:

- The world celebrates the International Day of Forests on March 21 every year with the aim to increase awareness about the unprecedented role forests play in sustaining lives on this planet.
- The theme for 2022 is "Forests and sustainable production and consumption."
- The United Nations General Assembly proclaimed 21 March the International Day of Forests (IDF) in
   2012.

## World Sparrow Day 2022:

- World Sparrow Day is celebrated on 20th March every year and puts the spotlight on the tiny-chirpy
   House Sparrow and other birds.
- The theme of World Sparrow Day is "LOVE Sparrows."

- World Sparrow Day was established by Mohammed Dilawar, the founder of The Nature Forever Society.
- The first World Sparrow Day was held in the year 2010.

## World Poetry Day-21 MARCH

- World Poetry Day is celebrated on 21 March, and was declared by UNESCO in 1999, with the
  aim of supporting linguistic diversity through poetic expression and increasing the opportunity for
  endangered languages to be heard.
- The United Nations Educational, Scientific, and Cultural Organization (UNESCO) adopted this day during UNESCO's 30th session in Paris in 1999.
- Some countries also celebrate World Poetry Day on October 15 to mark the birthday of Virgil, a
   Roman poet who is famous for his epic Aeneid.

## World Down Syndrome Day 2022:

- World Down Syndrome Day (WDSD) is observed annually on March 21.
- It is a global awareness day which has been officially observed by the United Nations since 2012.
- The theme of World Down Syndrome Day this year is "Inclusion Means".
- The first World Down Syndrome Day was observed in 2006.

## World Water Day- 22<sup>nd</sup> March:

- World Water Day is an annual United Nations observance day held on 22 March that highlights
  the importance of fresh water.
- The World Water Day theme 2022 is "Groundwater, Making the Invisible Visible".

## Shaheed Diwas or Martyrs Day-23rd March:

- March 23 every year is observed as Shaheed Diwas to mark the death anniversary of Indian freedom fighters Bhagat Singh, Shivaram Rajguru and Sukhdev Thapar.
- Also, 30 January is observed as Martyr's Day or Shaheed Diwas in the memory of Mahatma Gandhi.
- It was on March 23, 1931, when the three were hanged to death in the Lahore Central Jail in British India (now Pakistan) by Britishers.

## World Meteorological Day 2022:

- World Meteorological Day takes place every year on 23 March, commemorating the date in 1950
   when the Convention establishing the World Meteorological Organization came into force.
- This year World Meteorological Day is celebrated keeping the theme of Early Warning and Early
   Action.
- World Meteorological Day is celebrated as the establishment of the World Meteorological
   Organization (WMO), which was established on March 23, 1950.

## International Day for the Right to the Truth: March 24

- Each year, on 24 March, the International Day for the Right to the Truth Concerning Gross
  Human Rights Violations and for the Dignity of Victims is observed.
- This annual observance pays tribute to the memory of Monsignor Óscar Arnulfo Romero, who was murdered on 24 March 1980.

## World TB Day: 24 March

- World Tuberculosis Day, observed on 24 March each year, is designed to build public awareness
  about the global epidemic of tuberculosis and efforts to eliminate the disease.
- The theme of World TB Day 2022 Invest to End TB. Save Lives.

## Bihar Day: March 22

- The Bihar Diwas is celebrated every year on as it was on this day that the British carved out Bihar from Bengal Presidency in 1912.
- Bihar Diwas 2022 marks the 110th anniversary of the state's founding.

## International Day of Solidarity with Detained and Missing Staff Members:

- Every year, on 25th March the International Day of Solidarity with Detained and Missing Staff
   Members is observed by the United Nations.
- This day is observed by the UN with the aim of demanding justice, mobilizing action, and strengthening the resolve to protect the peacekeepers and personnel of the UN.

## International Day of Remembrance of the Victims of Slavery and the Transatlantic Slave Trade:

- Every year on 25 March, the International Day of Remembrance of the Victims of Slavery and the

- The International Day also aims to raise awareness about the dangers of racism and prejudice.
- It was first observed in 2008 with the theme Breaking the Silence, Lest We Forget".

## International Day of Solidarity with Detained and Missing Staff Members:

   Members is observed by the United Nations.
- This day is observed by the UN with the aim of demanding justice, mobilizing action, and strengthening the resolve to protect the peacekeepers

- The bank does not have adequate capital and earning prospects, as such, it does not comply
  with the provisions of Section 11(1) and Section 22 (3) (d) read with Section 56 of the Banking
  Regulation Act, 1949.
- The bank has failed to comply with the requirements of Section 22(3) (a), 22 (3) (b), 22 (3) (c),
   22 (3) (d) and 22 (3) (e) read with Section 56 of the Banking Regulation Act, 1949.

#### NABARD sanctions Rs 4,013cr financial assistance for Odisha

The National Bank for Agriculture and Rural Development (NABARD) has sanctioned Rs
 4,013 crore to the Odisha government under the Rural Infrastructure Development Fund
 (RIDF) during the financial year 2021-22.

- With an assistance of Rs 2,568 crore (64 percent of the state's total sanction) has been sanctioned for construction of rural roads.

an alternative to chemical-based pesticides and help farmers protect their crops from bacterial
and fungal infections.

#### India's First FSRU Reaches At H-Energy's Jaigarh Terminal, Maharashtra

- India's first Floating Storage and Regasification Unit (FSRU), Hoegh Giant, arrived at H-Energy's Jaigarh terminal in Maharashtra.
- The FSRU has a **storage capacity** of **170,000 cubic metres** and has an installed **re-gasification** capacity of **750 million cubic feet per day (equivalent to 6 million tons annually).**

#### DRDO Developed Monolithic Microwave Integrated Circuits Onboard EOS 04

• Defence Research and Development Organisation (DRDO) developed Monolithic Microwave Integrated Circuits (MMICs) that have been used in radar imaging satellite modules of EOS 04.

#### NASA Begins Assembling Europa Clipper Spacecraft

 NASA has started the assembly of a new spacecraft named Europa Clipper Spacecraft that will carry out the Europa clipper mission.

#### Petascale supercomputer "PARAM Ganga" established at IIT Roorkee

- The National Supercomputing Mission (NSM) has deployed 'PARAM Ganga', a supercomputer at IIT Roorkee, with a supercomputing capacity of 1.66 Petaflops.
- The system is designed and commissioned by C-DAC under phase-2 of the build approach of the NSM.
- The facility was inaugurated by BVR Mohan Reddy, chairman, board of governors, IIT Roorkee.

#### NASA rolls out Artemis 1 moon mission to the launch pad for 1 st time

- National Aeronautics and Space Administration 's Artemis 1 mega moon rocket was rolled out for the first time for its testing debut at Kennedy Space Center in Florida, USA.
- The agency's huge crawler-transporter 2 vehicle began hauling the Space Launch System
   (SLS) rocket and Orion capsule from KSC's Vehicle Assembly Building to Pad 39B
- The Space Launch System is the only rocket capable of sending humans into deep space.

## "Relativistic Klystron Amplifier": Laser weapon capable of destroying satellites developed by China

- Researchers in China have developed a microwave machine "Relativistic Klystron Amplifier (RKA)", that could jam or destroy satellites in space.
- The device can generate a wave burst measuring 5-megawatts in the Ka-band, a portion of the electromagnetic spectrum increasingly used for both civil and military purposes.

## OneWeb partners with SpaceX to resume its LEO satellite launches

- Bharti Enterprises-led OneWeb, the low Earth orbit (LEO) satellite communications company
  has entered into an agreement with Elon Musk-owned SpaceX, which will enable it to resume
  satellite launches.
- The first launch with SpaceX is anticipated in 2022 and will add to OneWeb's total in-orbit constellation that is currently at 428 satellites, or 66 per cent of the fleet.

#### India Successfully Test-fires BrahMos Supersonic Cruise Missile From Andaman & Nicobar islands.

- India successfully test fired the extended range version of a surface-to-surface BrahMos
   supersonic cruise missile from a launch pad in the Andaman and Nicobar Islands.
- The BrahMos missile, which has been developed by the joint venture between Russia's NPO
   Mashinostroyeniya and India's Defence Research and Development Organisation (DRDO).
- These missiles fly at three times the speed of sound i.e. 2.8 Mach (Mach number is the ratio of an object's speed in a given medium to the speed of sound in that medium).
- The first air launch of BrahMos was successfully carried out from a Su-30MKI fighter aircraft in 2017.

#### North Korea confirms test-firing of biggest ICBM Hwasong-17

 North Korea test-fired its biggest-yet intercontinental range ballistic missile Hwasong-17 under the orders of authoritarian leader Kim Jong Un.

- The launch was North Korea's 12th round of weapons launches in 2022.
- The Hwasong-17, which has been shown on a transporter vehicle with 11 axles, would be one of the largest road-mobile ICBMs in the world if it becomes operational.
- It reached a maximum altitude of 6,248 kilometers (3,880 miles) and traveled 1,090 kilometers (680 miles) during a 67-minute flight before landing in waters between North Korea and Japan.

## HAL Introduces 19-Seater Civil Aircraft, to Deploy Under Udaan Scheme

- The UDAN Scheme is a key component of Prime Minister Narendra Modi's National Civil Aviation Policy (NCAP) which was released by the Ministry of Civil Aviation (India) on 15 June 2016.

## WB Governor Jagdeep Dhankhar i naugurates supercomputer PARAM Shakti at IIT Kharagpur

- On March 27, 2022, the Governor of West Bengal, Jagdeep Dhankhar, inaugurated a Petascale Supercomputer PARAM Shakti under the National Supercomputing Mission (NSM) - a joint initiative of the Ministry of Electronics and Information Technology (MeitY) and Department of Science and Technology (DST) at IIT Kharagpur.
- The system has been tested extensively by both IIT Kharagpur and CDAC for commercial, opensource and in-house software pertaining to diversified applications.

## Motor Vessel Ram Prasad Bismil becomes longest vessel ever to sail on Brahmaputra River

The Ministry of Ports, Shipping and Waterways has achieved a landmark when the motor vessel (MV) Ram Prasad Bismil became the longest vessel ever to sail on the Brahmaputra river.

- The 90 meters long flotilla is 26 meters wide, loaded with a draft of 2.1 meters, successfully completed the aspiring pilot run of heavy cargo movement from Haldia Dock in Kolkata after it anchored at Pandu port in Guwahati.
- The vessel along with two barges DB Kalpana Chawla and DB APJ Abdul Kalam were flagged
  off from the Syama Prasad Mookerjee Port in Haldia by Union Minister of Ports, Shipping &
  Waterways (PSW) and AYUSH, Sarbananda Sonowal flagged them off on February 16.

#### ICG's 5th Offshore Patrol Vessel (OPV) Saksham Commissioned In Goa

- Defence Secretary Dr Ajay Kumar commissioned Indian Coast Guard Ship (ICGS) Saksham, the fifth in the series of 105-metre Offshore Patrol Vessels (OPVs) class, at Goa.
- The OPV has been designed and built indigenously by Goa Shipyard Limited and fitted with advanced technology, navigation and communication equipment, sensors and machinery.
- It is designed to carry a **twin-engine helicopter** and four high-speed boats including two inflatable boats for boarding operation, search & rescue, law enforcement and maritime patrol.

- Design check and technical support has been provided by the teams of IIT Madras and IIT
   Roorkee.

#### 9th India-Seychelles Joint Military Exercise 'LAMITIYE-2022'

- The 9th Joint Military Exercise LAMITIYE-2022 between the Indian Army and Seychelles Defence
  Forces (SDF) is being conducted at Seychelles Defence Academy (SDA), Seychelles from 22
  March to 31 March 2022.
- The Indian Army contingent comprises troops from the 2/3 GORKHA RIFLES group (PIRKANTHI Battalion).
- Exercise LAMITIYE-2022 is a biennial training event which has been conducted in Seychelles since 2001.

- The 2nd edition of DUSTLIK was conducted in Ranikhet (Uttarakhand) in March 2021.
- The 1st edition of DUSTLIK was held in Uzbekistan in Nov 2019.

#### Malaysia to host 4 nations for Bersama Shield 2022 military drills

- Malaysia will host armed forces from Australia, New Zealand, Singapore and the United Kingdom
  in the annual Bersama Shield 2022 training exercise.
- The exercise, referred to as BS22, is conducted within the framework of the Five Power Defense
   Arrangements (FPDA) a series of bilateral and multilateral defense agreements established in

   1971.
- Bersama means together in Malay.

#### Defence Ministry approves military acquisitions worth Rs 8,357 crore

- The Defence Acquisition Council (DAC), which met under the chairmanship of Defence Minister Rajnath Singh, accorded Acceptance of Necessity (AoN) for capital acquisition proposals of armed forces worth ₹8,357 crore.
- The approved proposals included "procurement of night sight (image intensifier), light vehicles GS
   4X4, air defence fire control radar (light) and GSAT-7B satellite.
- As an impetus to "Aatmanirbhar Bharat", all of the aforementioned proposals have been approved under "Buy Indian (IDDM)" category.

## Exercise Suraksha Kavach 2- Joint Security Exercise by Indian Army and Maharashtra Police

- On March 22, 2022, Agnibaaz Division organized a joint exercise between Indian Army and
   Maharashtra Police at Lullanagar, Pune.

#### India Successfully test-fires two MRSAMs off Odisha coast

- India successfully test–fired two Army–version Medium Range Surface–to Air–Missiles (MRSAMs) from the Integrated Test Range at Chandipur in Odisha.
- The MRSAM version is developed jointly by the DRDO and the Israel Aerospace Industries (IAI)
   for the Army.
- The first launch was to intercept a medium-altitude long-range target and the second launch was
  for proving the capability of a low altitude short-range target.
- The MRSAM Army weapon system comprises a multi-function radar, mobile launcher system and other vehicles.

#### US & Philippines begins 'Balikatan 2022' largest-ever military drills

- On March 28, 2022, The United States military and the Philippines military started the large-scale annual joint military drills in the Southeast Asian country Balikatan 2022.
- The exercise will take place across Luzon in the Philippines region near Taiwan, from March 28 to April 8, 2022.
