## 2022 Govt Schemes - January

### **Central Government Schemes**

### Himachal Pradesh becomes 1st LPG enabled & smoke free Indian state

Himachal Pradesh (HP) has become the first LPG (Liquefied petroleum gas) enabled and smoke free Indian state. This success is backed by the Central Government's Pradhan Mantri Ujjwala Yojana (PMUY) scheme and HP Government's Mukhya Mantri Grihini Suvidha Yojana (GSY). While the PMUY scheme aims to get rid of the diseases caused by smoke and freeing women of the country from indoor pollution, the GSY objective is to cover those families which are not covered under PMUY.

### WFP & TAPF Partners to Enhance PM POSHAN Scheme

United Nations(UN)'s World Food Programme (WFP) in India, has partnered with The Akshaya Patra Foundation (TAPF), a not-for-profit organisation, to enhance the effectiveness of the Pradhan Mantri – Poshan Shakti Nirman (PM POSHAN) scheme (earlier known as National Programme for Mid-Day Meal in Schools).

The partnership aims to enhance food safety and hygiene projects, capacity building of cooks-cumhelpers and nutritional quality of school meals.

### UJALA Completes 7 years; Saves ~48 Bn kWh Energy Every Year

Power Ministry successfully completed 7 years of distributing and selling LED lights under its flagship Unnat Jyoti by Affordable LEDs for All (UJALA) programme.UJALA initiative is the world's largest zero subsidy domestic lighting programme with more than 78 crore LEDs distributed across the country.

## 2022 Govt Schemes - February

### **Central Government Schemes**

### Ministry of Heavy Industries Notifies Phase II of Capital Goods Scheme

Ministry of Heavy Industries (MHI) has notified "Scheme on Enhancement of Competitiveness in the Indian Capital Goods Sector- Phase-II" for providing assistance to Common Technology Development and Services Infrastructure with the financial outlay of Rs. 1207 crores.

✓ Out of the total financial outlay, the budgetary support will be Rs 975 crore and the remaining Rs 232 crore would be the contribution from industry.

## Government approves continuation of Scheme of Assistance to NSFs with an outlay of Rs. 1575 crore

Union Government approved the continuation of Scheme of Assistance to National Sports Federations (NSFs) with an outlay of Rs. 1575 crore for 15<sup>th</sup> Finance Commission Cycle (2021-22 to 2025-26). The Scheme of Assistance to NSFs is the flagship Central Sector Scheme (CSS), that provides financial support to the Ministry of Youth Affairs and Sports. It is the main source of funding for preparation of national athletic teams for all major National and International competitions.

### Ministry of Tourism Included Punaura Dham under PRASHAD Scheme

Ministry of Tourism has included the destination of **Punaura Dham** in Sitamarhi in the Ramayana Circuit of Swadesh Darshan Scheme. The Punaura Dham has been included under the **PRASHAD** Scheme (Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive) of the Ministry of Tourism, Government of India. This was proposed by the State government of Bihar.

✓ Punaura Dham, located in Punaura village, is the birthplace of Goddess Sita.



### **Government Continues RYSK Scheme for Another 5 years**

Central Government has decided to continue the Scheme of "Rashtriya Yuva Sashaktikaran Karyakram (RYSK) for another 5 years from 2021 -22 to 2025-26 with an outlay of Rs. 2,710.65 crore rupees to develop the personality and leadership qualities of the youth and to engage them in nation building activities. The RYSK scheme is the flagship Central Sector Scheme of the Ministry of Youth Affairs and Sports.

✓ **Beneficiaries** – The youth in the age-group of 15 to 29 years (according to the definition of 'youth' in the National Youth Policy, 2014).

### PMKSY Scheme Extended till FY26 with Rs 4,600 Crore Outlay

Pradhan Mantri Kisan SAMPADA Yojana (**PMKSY**), a flagship scheme of the Ministry of Food Processing Industries (MoFPI) has been extended for a period of 2021-2022 to 2025-2026 (till March 2026). The government of India (GoI) has allocated Rs 4600 crore for the scheme. The GoI launched the Scheme for Agro-Marine Processing and Development of Agro-Processing Clusters (**SAMPADA**) in 2017 with an allocation of Rs 6000 crore.

### MoSJE Minister Dr. Virendra Kumar Launches Welfare Scheme "SMILE"

Ministry of Social Justice and Empowerment (MoSJE) Minister Dr.Virendra Kumar Launches Central Sector scheme "SMILE: Support for Marginalised Individuals for Livelihood and Enterprise" at New Delhi with outlay of Rs 365 Crore for 2021-22 to 2025-26. The Scheme is designed by Department of Social Justice & Empowerment.

- ✓ The purpose of the initiation is to provide welfare and rehabilitation to the Transgender community and the people engaged in the act of begging.
- ✓ There are 2 sub-schemes under this scheme which includes 'Central Sector Scheme for Comprehensive Rehabilitation for Welfare of Transgender Persons' and 'Central Sector Scheme for Comprehensive Rehabilitation of persons engaged in the act of Begging'.

### Govt sanctions construction of 60,000 homes under PMAY(U) in 5 States

Central Government of India gave approval to the project proposals for the construction of more than 60,000 houses in 5 states including Andhra Pradesh, Chhattisgarh, Himachal Pradesh, Karnataka and Rajasthan under the Pradhan Mantri Awas Yojana – Urban (**PMAY-U**) during the 58th meeting of Central Sanctioning and Monitoring Committee (CSMC). The virtual meeting was chaired by Manoj Joshi, Secretary, Ministry of Housing and Urban Affairs (MoHUA).

✓ A booklet titled 'Transformative Reforms Towards Housing for All' was released by Manoj Joshi, Secretary, MoHUA.

Proceedings of 'Awas Par Samvaad' also released. It is the first- of-its-kind initiative in the urban housing sector.

### Ministry of Education Approved "NILP" a new scheme of Adult Education

Ministry of Education (MoE) approved a new scheme "New India Literacy Programme (NILP) which is also known as Nav Bharat Literacy Program" for upcoming 5 years (FY 2022-27) to cover all the aspects of adult education to align with National Education Policy (NEP) 2020.

✓ MoE replaced the term "Adult Education" with "Education for All" to cover non-literates of the age of 15 years and above with the help of "Online Teaching, Learning and Assessment System (OTLAS)" in collaboration with National Informatics Centre, National Council of Educational Research and Training (NCERT) and National Institute of Open Schooling (NIOS).

The total estimation of NILP is Rs.1037.90 crore, in which the Central government and State government share Rs 700 crore and Rs 337.90 crore respectively.



### Government Extends Capacity Development Scheme till March 31,2026

Union Cabinet approved for the continuation of the Capacity Development (CD) scheme of Ministry of Statistics & Programme Implementation (MoSPI) till 31st March 2026 or further review, whichever is earlier with an outlay of Rs. 3,179 crores approved during 15th Finance Commission.

✓ The scheme comprises the main scheme, capacity development and two sub schemes viz. Support for Statistical Strengthening (SSS) and Economic Census (EC).

### Rajasthan Tops Solar Electrification under Saubhagya Scheme

Rajasthan has the maximum households electrified through the 'solar-based standalone system' under the Pradhan Mantri Sahaj Bijli Har Ghar Yojana – 'Saubhagya' scheme launched by the Centre in October 2017.

**Aim** – To achieve universal household electrification by providing last mile grid connectivity and electricity connections to all households in rural and all poor households in urban areas.

#### Government Approves Continuation of RUSA Scheme till 31st March 2026

The Government has approved the continuation of Rashtriya Uchchatar Shiksha Abhiyan (RUSA) scheme till 31st March 2026 with an expenditure of 12,929.16 crore rupees. The new phase of the scheme would support around 1,600 projects.Out of Rs 12,929.16 crores of expenditure, the centre will share Rs 8,120.97 crore and the state will share Rs 4,808.19 crore.

✓ The new phase of the scheme has been designed to implement some of the recommendations of the New Education Policy (NEP).

### Govt Enters Its 7th Year of Implementing PMFBY & To Launch 'Meri Policy Mere Hath'

The government has successfully entered into the 7th year of implementing **Pradhan Mantri Fasal Bima Yojana (PMFBY)**, since its launch on 18th February 2016 by Prime Minister Narendra Modi at Sehore, Madhya Pradesh (MP). PMFBY will launch 'Meri Policy Mere Hath' drive.

✓ The PMFBY scheme will be launching a doorstep distribution drive, 'Meri Policy Mere Hath' to deliver crop insurance policies to the farmers in all implementing States in the upcoming Kharif season.



### Central Govt approved continuation of Umbrella scheme of BIM from 2021-22 to 2025-26

Central Government approved the continuation of the Central Sector Umbrella Scheme of 'Border Infrastructure and Management (BIM)' over the 15<sup>th</sup> Finance Commission Cycle from 2021-22 to 2025-26, at a cost of Rs 13,020 crore. The Ministry of Home Affairs (MHA) is responsible for the improvement of BIM. This continuation will strengthen the border infrastructure for improving border management, policing and guarding the borders.

### MoW&CD extends PM CARES for Children Scheme till February 28 2022

Ministry of Women and Child Development (MoW&CD) extended the time period Prime Minister's Citizen Assistance and Relief in Emergency Situations Fund (**PM CARES**) scheme for Children till 28 February 2022 (earlier, valid till 31 December 2021). It covers all children who have not completed 18 years of age at the time of death of their parents, surviving parent, legal guardian, adoptive parents or single adoptive parent due to COVID 19 pandemic. Starting from 11 March 2020 to 28 Feb 2022.

### Gol Celebrates 3rd Anniversary of PM-KISAN

24<sup>th</sup> February 2022, marks the 3<sup>rd</sup> anniversary of Pradhan Mantri Kisan Samman Nidhi (**PM-KISAN**) Scheme. It was launched on 24<sup>th</sup> February in 2019 by Prime Minister Narendra Modi at Gorakhpur, Uttar Pradesh to provide income support to all landholding farmer's families irrespective of the land size in order to meet their expenses related to agriculture and domestic needs. It is 100% Funded by the central government under the Ministry of Agriculture and Farmers Welfare (MoAFW).

✓ Under the Scheme, Farmers will receive an amount of Rs.6000 per year in 3 equal instalments of Rs.2000 directly into their bank accounts.

### Gol Approves Continuation of IVFRT Scheme till March 2026

Government of India (GoI) has approved for the continuation of **Immigration Visa Foreigners Registration Tracking (IVFRT) Scheme** till March 31, 2026 with a period of five years which starts from April 1,2021 and its financial outlay is Rs 1,364.88 crore. In order to Modernize and upgrade the Immigration services, "**Immigration, Visa and Foreigners Registration & Tracking (IVFRT)**" has been identified and included as one of the MMPs to be undertaken by the Ministry of Home Affairs under the National e-Governance Plan (NeGP).

✓ The aim of IVFRT Scheme is to provide a secure and integrated service delivery framework that facilitates legitimate travellers by strengthening national security.

### **State Government Schemes**

### MP Govt Announces Welfare Schemes on Ravidas Jayanti

Madhya Pradesh Chief Minister (CM) Shivraj Singh Chouhan announced welfare schemes for Scheduled Caste (SC) communities, including one related to self-employment on the occasion of birth anniversary of Guru Ravidas,i.e 16th February. He made an immense contribution towards upliftment of Scheduled Caste (SC) communities.

✓ The MP government announced that the Global Skill Park, to be built in Bhopal and it would be named after Guru Ravidas.

## Govt Launches Doorstep Crop Insurance Distribution Drive 'Meri Policy, Mere Hath' under PMFBY

Union agriculture minister Narendra Singh Tomar launched the central government's 'Meri Policy, Mere Hath', a doorstep crop insurance policies distribution drive under Pradhan Mantri Fasal Bima Yojana (PMFBY) in Sanwer tehsil of Indore district, Madhya Pradesh, to deliver crop insurance policies to farmers. The PMFBY enters the 7th year of implementation with the upcoming Kharif season.

# Govt. approved continuation of 7 sub-schemes under 'Relief and Rehabilitation of Migrants and Repatriates' from 2021-22 to 2025-26

The Government of India approved the proposal for continuation of the seven existing sub schemes under the Umbrella Scheme "Relief and Rehabilitation of Migrants and Repatriates" for the period 2021-22 to 2025-26 with a total outlay of Rs.1,452 crore.

The scheme will aid and assist the migrants and repatriates to earn a reasonable income and promote their inclusion in economic activities.

### MoMA Extends the Deadline of Qaumi Waqf Boards Taraqqiati Scheme

Ministry of Minority Affairs (MoMA) has extended the deadline for the Qaumi Waqf Boards Taraqqiati Scheme (QWBTS) (Former Scheme of Computerization of Records & Strengthening of State Waqf Boards) (geotagging the Waqf properties) from March 2022 to November 2023. The Central Waqf Council, New Delhi is the Nodal Agency for implementation of the Scheme. The aim of the scheme is to map the immovable assets under the Waqf boards, to ensure its proper utilisation and monetisation.

### Gol Approves Modernisation Plan-IV for CAPFs with a financial outlay of Rs 1,523 crore

Government of India (GoI) has approved 'Modernisation Plan-IV for Central Armed Police Forces (CAPFs)' scheme to improve the overall operational efficiency and preparedness of the CAPFs with a financial outlay of Rs 1,523 crore. The Ministry of Home Affairs under guidance of Union Home Minister, Amit Shah will implement the scheme from 1st February 2022 to 31st March 2026.

### Labour Ministry launches 'Donate-a-Pension' initiative under PM-SYM

Union Minister Bhupender Yadav, Ministry of Labour & Employment (MoL&E), has launched 'Donate-a-Pension' programme under Pradhan Mantri Shram Yogi Maan-Dhan Yojana (PM-SYM) for people to contribute to the pension fund to their support staff. This initiative is one of the events planned by MoL&E, for the 'Iconic Week' celebration observed from 7th to 13th March 2022, which is a part of 'Azadi Ka Amrit Mahotsav'.

### Central Govt approved continuation of Swatantrata Sainik Samman Yojana till FY26

Central Government has approved the continuation of **Swatantrata Sainik Samman Yojana (SSSY)** for Financial Years 2021-22 to 2025-26. The total outlay SSSY is Rs 3,274.87 crore. Under SSSY freedom fighters and their eligible dependents are given pension and other financial benefits, till 2025-26. The proposal for continuation of the SSSY was received from the Ministry of Home Affairs (MHA) under Union Minister Amit Shah.



### **State Government Schemes**

### Chhattisgarh CM launches 'Kaushalya Matritva Yojana' for safe Motherhood

Chief Minister (CM) of Chhattisgarh Bhupesh Baghel in Raipur launched the 'Kaushalya Matritva Yojana' by handing cheques of Rs 5,000 each to five women beneficiaries for the safe motherhood practices. Under this scheme, financial assistance of Rs 5000 will be provided to women for bringing up their second girl child.

### Sikkim Govt. to launch Aama Yojna & Bahini Scheme

Chief Minister of Sikkim, Prem Singh Tamang has announced that the State Government will soon implement 'Aama Yojna', a scheme for helping non-working mothers & 'Bahini Scheme' benefitting girl students of the state. The scheme aims to inculcate the habit of saving among non-working mothers in the state and hence the Govt. will provide them Rs. 20,000 each in their bank accounts annually.

### Pradhan Mantri MUDRA Yojana completes 7 years on April 8, 2022

April 08, 2022 marked the 7th anniversary of **Pradhan Mantri MUDRA (Micro Units Development & Refinance Agency) Yojana** (PMMY) which was launched on April 8, 2015 by the Prime Minister (PM) of India Narendra Modi.

- ✓ Purpose: To provide loans up to Rs 10 lakh to the non-corporate, non-farm small/microenterprises, along with creation of income generating activities.
- ✓ It's a Central Government Scheme to 'fund the unfunded'.

#### Stand-Up India Scheme Marks Sixth Anniversary

The Stand-Up India scheme has completed 6 years on April 5, 2022, since its launch on **April 5, 2016,** by Prime Minister Narendra Modi. It is extended till 2025.

✓ Launched by: The Department of Financial Services (DFS), Ministry of Finance
Purpose: To promote entrepreneurship at the grass-root level of economic empowerment and job

creation.

Designated Stand-Up Connect Centres (SUCC): Small Industries Development Bank of India (SIDBI) and National Bank for Agriculture and Rural Development (NABARD).

### NHA launched HBP under AB-PMJAY Adding 365 New Procedures

During the 3rd edition of two day 'Ayushman Sangam', a meeting held in Mahabalipuram (Tamil Nadu) the National Health Authority (NHA) has launched a new version of the Health Benefit Package (HBP), 2022, under the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), by adding 365 new procedures and making the total of about 1,949 procedures.

✓ HBP is to review the AB-PMJAY and Ayushman Bharat Digital Mission in Southern States and Union Territories.

Third edition is covering the Andaman and Nicobar Islands, Andhra Pradesh, Karnataka, Kerala, Lakshadweep, Puducherry, Tamil Nadu and Telangana.

### Central Govt Raises Rs 1tn Via Asset Monetization in FY22, Beats Target By 12%

Under the National Monetisation Pipeline (NMP) i.e., Central Government's asset monetization, the public sector **brownfield asset** generated revenues and investments worth Rs 1 trillion (tn), 12% more than



the target set for FY22. In aggregate, revenues and investments mobilized from asset monetization in FY22 stood at **Rs 96,000 crore**, which will go up by at least Rs 4,000 crore after some additional data.

✓ The government has set a target of Rs 6 lakh crore (6 trillion) through 4-year National Monetisation Pipeline (NMP)/asset monetization in FY22-25. Click here to read about NMP

### Pradhan Mantri Garib Kalyan Package Extended for a Period of 180 days

The Central Government extended Pradhan Mantri Garib Kalyan Package (PMGKP) for a further period of 180 days w.e.f. April 19, 2022. The focus behind this extension to continue providing the safety net to the dependents of health workers who are taking care of COVID-19 patients.

✓ The PMGKP was launched on March 30, 2020, it provides comprehensive personal accident cover of **Rs 50 Lakh** to 22.12 lakh health care providers including community health workers and private health workers who have been in direct contact of COVID-19 patients and are at risk of being impacted by this.

### Govt Eases Certain Norms under EPCG Scheme to Promote Ease of Doing Business

The Ministry of Commerce and Industry has relaxed certain norms under **chapter 5** of Export Promotion Capital Goods (**EPCG**) Scheme Handbook of Procedures (2015-20) issued under Foreign Trade Policy (**FTP**) 2015-20, in order to reduce compliance requirements and facilitate ease of doing business. **Objective**: to facilitate import of capital goods for producing quality goods and services and enhance India's manufacturing competitiveness.

✓ Under the EPCG scheme, Capital Goods imports will be allowed duty free provided, the exporter or the authorisation holder has to export finished goods worth six times of the actual duty saved in value terms in six years.

#### Total Enrolment in APY Scheme Crossed 4.01 Crore as On March 2022

In accordance with the Ministry of Finance, as on March 2022, the total enrollments under the Central Government's retirement benefits scheme Atal Pension Yojana (APY) have crossed 4.01 crore out of which more than 99 lakh APY accounts were opened during FY 2021-22.

- ✓ Atal Pension Yojana is the guaranteed pension scheme of Government of India administered by Pension Fund Regulatory and Development Authority (PFRDA).
- ✓ Under the scheme, a subscriber would receive a minimum guaranteed pension of Rs.1000 to Rs. 5000 per month from the age of 60 years, depending upon his contribution.

## JK's Samba Becomes 1st District in India to Cover 100% Households under AB-PMJAY- SEHAT Scheme

The Union Territory (UT) of Jammu and Kashmir's (J&K) **Samba District** has become the first district in India to **cover 100** % households under Ayushman Bharat Pradhan Mantri Jan Arogya Yojana **(AB-PMJAY)- SEHAT** (Social, Endeavour for Health and Telemedicine) scheme.

- ✓ The SEHAT Scheme was launched in convergence with AB-PMJAY for the entire UT of Jammu and Kashmir on 26 December 2020.
- ✓ The aim of the scheme is to extend health insurance coverage to all residents of UT of J&K. The scheme has no cap on Family size and Age criteria.

### Unnat Bharat Abhiyan 2.0 Completes Four Years, Launched on 25th April 2018

The Unnat Bharat Abhiyan (UBA) 2.0 on April 25, 2022 has completed four years since its launch on the same day in the year 2018.

✓ The UBA 2.0 was launched with the vision of transformational change in the rural development processes by the Ministry of Education (MoE). IIT Delhi -designated to function as the National Coordinating Institute for this program.



✓ The UBA (UBA 1.0) is a flagship program of the Ministry of Education (formerly Ministry of Human Resource and Development) on 11th November, 2014. UBA 2.0 is the upgraded version of UBA 1.0, launched in 2018.

## MP govt Launches 'Mukhyamantri Udyam Kranti Yojana' to Give Loan up to Rs 50L with Subsidized Interest Rate for Self-employment

Madhya Pradesh (MP) Chief Minister, Shivraj Singh Chouhan launched 'Mukhyamantri Udyam Kranti Yojana' at Kushabhau Thakre International Convention Center to give loan up to Rs 50 Lakhs with subsidized interest rate for self-employment. Implemented by MP's Dept. of MSME.

The government will give 3 percent interest subsidy and bank loan guarantee fee for a maximum period of 7 years in the form of financial assistance to the beneficiaries of "Mukhyamantri Udyam Kranti Yojna".

# National Behaviour Change Communication Framework for Garbage-Free Cities Launched by Swachh Bharat Mission-Urban 2.0.

Manoj Joshi, Secretary, Ministry of Housing and Urban Affairs (MoHUA), has launched the "National Behaviour Change Communication Framework for Garbage Free Cities," a Swachh Bharat Mission-Urban 2.0 (SBM-U 2.0) initiative under the aegis of MoHUA. The objective of the framework is to strengthen the ongoing Jan Andolan (mass movement) for "Garbage-Free Cities."

- ✓ The SBM-U is extended for 5 years, from October 1, 2021 to October 1, 2026, as Swachh Bharat Mission-Urban 2.0 (SBM-U 2.0), to ensure that the SBM-U's achievements are continued in the long run.
- ✓ Following the launch of the National Behaviour Change Communication Framework for Garbage Free Cities, the second edition of 'SwachhTalks- 'Swachhata Ki Jyot', a virtual event, was also launched. Click here to know more about SBM-U 2.0

### Union Minister of MSME, Narayan Rane Launched (ZED) Certification Scheme

Union Minister for Micro, Small and Medium Enterprises (MSME), Narayan Tatu Rane launched the MSME Sustainable Zero Defect Zero Effect (ZED) Certification Scheme. The scheme focuses to reduce wastage substantially, increase productivity, enhance environmental consciousness, save energy, optimally use natural resources, expand their markets, etc., The scheme comprises three certification levels including bronze, silver and gold.

✓ Under the ZED certification scheme, the MSMEs will get subsidies in enterprises such as: Micro Enterprises: 80%; Small Enterprises: 60%; Medium Enterprises: 50%.

Also, there will be an additional subsidy of 5% for MSMEs which are a part of the Scheme of Fund for Regeneration of Traditional Industries (SFURTI) Or Micro & Small Enterprises – Cluster Development Programme (MSE-CDP).

### **SVAMITVA Scheme marks 2nd year Anniversary**

Survey of Villages Abadi and Mapping with Improvised Technology in Village Areas

- SVAMITVA scheme marked its 2nd year anniversary on 24th April 2022. The scheme was



launched by the Prime Minister Narendra Modi on **24th April 2020** on the occasion of National Panchayati Raj Day 2020.

It is a Central Sector Scheme of the Ministry of Panchayati Raj (MPR) launched nation-wide on National Panchayati Raj Day, **24th April 2021** after successful completion of pilot phase of scheme (2020-2021), which was implemented during 2020–2021 in the States of Maharashtra, Karnataka, Haryana, Uttar Pradesh, Uttarakhand, Madhya Pradesh and select villages of Punjab and Rajasthan.

### PMJJBY, PMSBY, and APY complete 7 years of providing Social Security net

- ✓ NPS is now regulated under PFRDA Act, 2013.

- ✓ The Prime Minister's Employment Generation Programme (PMEGP) is the flagship scheme of the Ministry of Micro, Small & Medium Enterprises (MSME) implemented to facilitate generation of employment opportunities for unemployed youth across the country by assisting the setting up of micro-enterprises in the non-farm sector. The National Health Authority (NHA) under its flagship scheme of Ayushman Bharat Digital Mission (ABDM) launched ABDM public dashboard for real-time information sharing and to act as a one-stop solution for information on the ABDM's progress at state or Union Territory (UT) level.

The ABDM is built on the core principles of accessibility, transparency, inclusivity and interoperability.
- ✓ The ABHA number generation facility is also available via several popular digital health applications like CoWIN, Pradhan Mantri Jan Arogya Yojana (PMJAY), Aarogya Setu, Government of Andhra Pradesh, e-Sushrut Railway Hospital, etc.

## Government Of India Hikes Premium Rates for Flagship Insurance Schemes PMJJBY & PMSBY For the First Time In 7 Years

The Government of India (GoI) has hiked the insurance premium rates for the **Pradhan Mantri Jeevan Jyoti Bima Yojana** (PMJBY) and **Pradhan Mantri Suraksha Bima Yojana** (PMSBY) to make them economically viable.

- ✓ The revision in premium rates is the first in seven years since the schemes' commencement in 2015. The revised premium rates will be effective from June 1, 2022.
- ✓ The premium rates for both schemes have been revised by making it Rs 1.25 per day, that includes revising PMJJBY from Rs. 330 per annum to Rs. 436 per annum and PMSBY from Rs. 12 per annum to Rs. 20 per annum.
- ✓ The PMJJBY is a renewable one-year life insurance scheme that provides death coverage.
- ✓ The PMSBY is a one-year renewable personal accident insurance policy that covers death or disability caused by an accident. The insurance coverage period runs from June 1 to May 31. Click here to read more about the revised rates of the schemes

- ✓ The objective of PMMSY-MIS is to monitor the PMMSY scheme activities and their progress in all participating States/Union Territories (UTs) & to strategically utilise the information for informed decision-making.

India aims to double marine product exports to Rs.1 lakh crore in the next 5 years from the present around Rs 50,000 crore.

### UDAN celebrates 2022 as its 5th Anniversary Year

Central Government scheme Ude Desh ka Aam Naagrik (**UDAN**) i.e., let the country's common man fly, is celebrating its fifth anniversary in 2022. This first of its kind scheme, headed by the **Ministry of Civil Aviation** (MoCA), stimulates **Regional Connectivity Scheme** (RCS) through a market-based mechanism. **UDAN** in Hindi means "**flight**"

- ✓ The **Airports Authority of India** (AAI) is its implementing agency.
- ✓ Launched in October 2016, it is a regional airport development programme of upgrading underserved air routes. It makes regional air connectivity affordable through: Concessions by Central Government, State Governments and airport operators & Financial (Viability Gap Funding or VGF) support.

# Agnipath Scheme: Govt Increased Upper Age Limit to 23 years; Defence Minister approves 10% reservation of jobs for Agniveers

Amid the protest against Agnipath Scheme (to recruit soldiers only for 4 years), The government of India (GoI) has granted a **one-time waiver for the proposed recruitment cycle for 2022** and increased the upper age limit for the recruitment process for **Agnipath Scheme for 2022** from 21 years to **23 years**.

✓ Previously, on the commencement of the scheme the entry age for all new recruits has been fixed as 17 and half to 21 years of age.

The 10% reservation will be implemented in the Indian Coast Guard (ICG) and defence civilian posts, and all the 16 Defence Public Sector Undertakings (PSUs)



### Garib Kalyan Rojgar Abhiyaan Completes Two Years

The Government of India launched Garib Kalyan Rojgar Abhiyaan **(GKRA)** on **20th June in 2020** for a period of 125 days with a resource envelope of **50,000 crore rupees** to boost employment and livelihood opportunities for returnee migrant workers in the wake of COVID-19 pandemic. The scheme has completed 2 years in 2022.

- ✓ The Ministry of Rural Development is the nodal Ministry and is implemented in close coordination with the State Governments.
- ✓ The scheme enhances long term livelihood opportunities by giving focus on 25 works in 116 selected districts across six states Bihar, Jharkhand, Madhya Pradesh, Odisha, Rajasthan and Uttar Pradesh.

A total of 12 Ministries and Departments of Government of India participated in GKRA and a total of 50.78 crore person-days employment was generated.

- ✓ Under PMFME, the digital GIS **One District One Product (ODOP)** map of India was also developed to provide details of ODOPs of all the States and UTs.

#### **MoWCD** issues Guidelines for Mission Shakti Scheme

The Ministry of Women and Child Development (MoWCD) issued detailed guidelines for the 'Mission Shakti' scheme. It will be applicable w.e.f. April 1, 2022.

✓ Under the guidelines, the Women Helplines (WHL) running under 181 number will be integrated with Emergency Response Support System number 112 for all emergency assistance and with One Stop Centre (OSC) and other platforms like 1098 Child line.

Government of India has launched 'Mission Shakti' – an integrated women empowerment programme during the 15th Finance Commission period 2021-22 to 2025-26. It has 2 sub-schemes - 'Sambal' – for the safety & security of women and 'Samarthya'- for the empowerment of women. Click here to read more.

- ✓ MEDISEP will provide coverage of up to **Rs.3 lakh per annum** for the eligible expenses incurred by the beneficiary for the listed procedures Basic Benefit Package (**BBP**) for three years.
